### **DESCRIPTION**

• Wattyl Natural (Scandinavian) Teak Oil is a two part system which utilises Wattyl ESTAPOL® Interior Polyurethane Matt (D5.19) and Natural Teak Oil to produce an attractive natural oil finish on teak or similar timbers. It is designed to impart a very smooth feel to the finish.

#### PRINCIPAL CHARACTERISTICS

- Suitable for interior use only.
- Imparts a dry but very smooth feel to the sealed timber surface.
- Duplicates the finish applied to Danish style furniture and interior décor.

Clean up Thoroughly clean equipment with mineral turps.

## RECOMMENDED SUBSTRATE CONDITIONS AND TEMPERATURE

- Suitable for use on interior domestic furniture, plywood panelling, lining boards, office furniture, staircase handrails, shop fittings etc.
- Ideal for rejuvenating previously sealed furniture.
- Not suitable on surfaces treated with a wax finish.
- Application **should not** be carried out if the air temperature or the substrate temperature is below 10°C or above 35°C.
  The temperature must not fall below 10°C during the drying process.
- New Timber

Ensure all new timber is free of dirt or grease and dry. Fill nail holes or cracks with Wattyl Timber Putty (D1.08) in a matching colour. Allow to dry. Sand smooth and remove dust.

## **INSTRUCTIONS FOR USE**

- Stir contents thoroughly with a flat stirrer before and during use.
- Stain if required with Wattyl Traditional Stain (D5.02) or Wattyl Colourwood Interior Stain (D5.01). Allow to dry.
- Apply two (2) coats Wattyl ESTAPOL® Matt (D5.19) at twelve (12) hours intervals then allow 48 hours to dry. Lightly sand along the grain with fine sandpaper and remove dust.
  - Wet the surface with Wattyl Natural Teak Oil and while wet, rug vigorously along the grain with a non soaped household steel wool pad until uniformly smooth. Remove surplus oil with a soft, clean cloth.
- Rejuvenating Oil Finished and previously sealed Furniture
  - Apply Wattyl Natural Teak Oil with a soft cloth and while wet rub vigorously along the grain. Wipe clean with a soft clean cloth.
