### 4. FIRST AID MEASURES

**Inhalation** Remove the source of contamination or move the victim to fresh air. Ensure airways are clear and give oxygen if breathing is difficult. Apply artificial respiration if not breathing. If symptoms develop and persist, seek medical attention.

**Ingestion** Do NOT induce vomiting. Wash out mouth with water. Seek medical attention.

**Skin** Wash affected area thoroughly with soap and water. Remove contaminated clothing and wash before reuse or discard. If symptoms develop seek medical attention.

**Eye** If contact with the eye(s) occurs, wash with copious amounts of water holding eyelid(s) open. Take care not to rinse contaminated water into the non-affected eye. If symptoms persist seek medical attention.

**First Aid Facilities** Eye wash and normal washroom facilities.

### 5. FIRE FIGHTING MEASURES

**Suitable Extinguishing Media** Use water fog, foam or dry chemicals.

<b>Hazards from Combustion Products</b>	Under fire conditions this product may emit toxic and/or irritating fumes including carbon monoxide and carbon dioxide.
<b>Specific Methods</b>	Use water spray to cool fire exposed containers.
<b>Specific Hazards</b>	This product is flammable. Keep storage tanks, pipelines, fire-exposed surfaces etc cool with water spray. Shut off any leak if safe to do so and remove sources of re-ignition. Vapour/air mixtures may ignite explosively. Flashback along the vapour trail may occur. Runoff to sewer may create fire or explosion hazard.

<b>Precautions in connection with Fire</b>	Fire-fighters should wear full protective clothing and self contained breathing apparatus (SCBA) operated in positive pressure mode.

## 6. ACCIDENTAL RELEASE MEASURES

<b>Emergency Procedures</b>	Wear appropriate personal protective equipment and clothing to minimise exposure. Extinguish or remove all sources of ignition and stop leak if safe to do so. Increase ventilation. Evacuate all unnecessary personnel. If possible contain the spill. Place inert absorbent, non-combustible material onto spillage. Use clean non-sparking tools to collect the material and place into a suitable labelled container for subsequent disposal. Dispose of waste according to the Environmental Protection Authority (EPA), federal, state and local regulations. If the spillage enters the waterways contact the EPA, or your local Waste Management Authority.

## 7. HANDLING AND STORAGE

<b>Precautions for Safe Handling</b>	Open containers cautiously as contents may be under pressure. Use only in a well ventilated area. DO NOT store or use in confined spaces. Do not enter these areas without respiratory protection or until the atmosphere has been checked. Keep tank covered and containers sealed when not in use. Build up of mists or vapours in the atmosphere must be prevented. Avoid inhalation of vapour and mists. Do not use near welding or other ignition sources and avoid sparks. Do NOT pressurise, cut, heat or weld containers as they may contain hazardous residues. Do not smoke. Exposure without protection should be prevented in order to lessen the possibility of skin disorders. It is essential that all who come into contact with this material maintain high standards of personal hygiene ie. Washing hands prior to eating, drinking, smoking or using toilet facilities.
<b>Conditions for Safe Storage</b>	Store in a cool, dry, well-ventilated area away from sources of ignition, oxidising agents, foodstuffs, and clothing and out of direct sunlight. Keep containers closed when not in use and securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Always keep in containers made of the same material as the supply container. Have appropriate fire extinguishers available in and near the storage area. Take precautions against static electricity discharges. Use proper grounding procedures. For information on the design of the storeroom, reference should be made to Australian Standard AS1940 - The storage and handling of flammable and combustible liquids. Reference should also be made to all State and Federal regulations.
